#### c. Fish (Joel Rigby) -

i. Joel presented on the programs he facilitated. **Fly Tying 101 – Kids Discovery Day March 12th, 2018**, this will be first of many. 5 students attended with a 2/3 split female to male ratio. ## e. Big Game - (Tedd Walcott)

i. The LFGA is the go to club for hunting in Southern Alberta. Tedd – mentored 13 first time and 18 novice hunters. - i. There is a clean up being organized at CPR Lake. It is being coordinated through ACA, Mike will notify LFGA when it is organized. Mike explained his work at ACA and LFGA for new members to understand what roles he plays. Expanding project east and west of the St. Mary Reservoir all the way to Medicine Hat.
